## General Information:

Green Lawngrer<sup>®</sup> TR is a concentrated dark green turf colourant which contains ColorLock™ technology, which provides resistance to undesirable colour shifts under normal UV light exposure.

Green Lawngrer<sup>®</sup> TR reduces UV-A and UV-B light transmission by 50%-70%, protecting turf against harmful UV radiation.

For use on golf courses. Do not use on athletic field (e.g., football or rugby fields) and residential lawns, due to a high colour transfer potential.

## Application:

Apply according to the table details below.

Application	Rate / Ha	Water Volume / Ha
Late autumn to early winter	Up to 5L	300L
Late winter to early spring*	Up to 2.5L	300L

\*A second application may be made 5-7 days later if packed snow or ice covering is especially deep and accelerated thawing is not initiated.

For best results, use a low to medium spray pressure and apply in two directions perpendicular to one another; two or more light sprays provide a better coverage and appearance than one heavy spray. Avoid overspray on any area where colour is not desired, otherwise permanent staining may occur. Accidental overspray may be removed by water prior to drying.

For the most uniform coverage, apply Green Lawngrer<sup>®</sup> TR with flat fan spray nozzles.

## ALWAYS FOLLOW PESTICIDE MANUFACTURER'S LABEL DIRECTIONS.

- Fill the sprayer tank 1/2 to 2/3 the total volume of water and begin agitation.
- Green Lawngrer<sup>®</sup> TR colourant should be added into the mix solution following the standard order of addition – after dry flowable / dispersible granules and before water-soluble pesticide formulations.
- Allow Green Lawngrer<sup>®</sup> TR colourant to fully disperse into the mix solution before adding additional soluble pesticides.
- Fill remainder of the sprayer tank to the desired volume with water.
- Apply pesticide solution to target site at the label rate specified by the manufacturer.

## Equipment Cleaning:

- After pesticide applications, always drain and clean the sprayer tank, pump, hoses, valves, and nozzles as per the label instructions of the pesticide manufacturer.

After initial rinsing, the use of a spray tank cleaner will facilitate further removal of pesticide residue from spray equipment.

Do not leave pesticide mix solutions with Green Lawngr® TR colourant in the sprayer tank overnight.

**STORAGE AND DISPOSAL:**

KEEP THE PRODUCT FROM FREEZING. Do not re-use empty containers. Safety goggles are recommended when handling the concentrate. If product is spilled, contain and absorb with inert material. Dispose of in accordance with local directions.
