SECTION 4: First-Aid Measures**4.1. Description of first aid measures**

SECTION 11: Toxicological Information**11.1. Information on toxicological effects**Acute toxicity

Assessment of acute toxicity:

Of moderate toxicity after short-term inhalation. Of moderate toxicity after single ingestion. Virtually nontoxic after a single skin contact.

Experimental/calculated data:

Long term administration of organotoxic doses revealed a carcinogenic effect. In long-term studies in mice in which the substance was given by feed, a carcinogenic effect was not observed.

Reproductive toxicity

Assessment of reproduction toxicity:

The product has not been tested. The statement has been derived from the properties of the individual components. The results of animal studies gave no indication of a fertility impairing effect.

Developmental toxicity

Assessment of teratogenicity:

The product has not been tested. The statement has been derived from the properties of the individual components.
